EFFECTIVE JANUARY 1, 1979, A SCHOOL DISTRICT MAY NOT INCREASE THE TOTAL AMOUNT OF TAX IT IMPOSED ON THE RESIDENCE HOMESTEAD OF AN INDIVIDUAL 65 YEARS OR OLDER ABOVE THE AMOUNT IT IMPOSED IN THE FIRST YEAR THE INDIVIDUAL QUALIFIED THAT RESIDENCE HOMESTEAD EXEMPTION.
