* STATE LAW REQUIRES SCHOOL DISTRICTS TO GRANT A \$25,000 EXEMPTION TO ALL RESIDENT HOMESTEADS AND AN ADDITIONAL \$10,000 EXEMPTION TO RESIDENT HOMESTEADS WHOSE OWNERS ARE 65 YEARS OF AGE OR OLDER OR DISABLED. EFFECTIVE JANUARY 1, 1979, A SCHOOL DISTRICT MAY NOT INCREASE THE TOTAL AMOUNT OF TAX IT IMPOSED ON THE RESIDENCE HOMESTEAD OF AN INDIVIDUAL 65 YEARS OR OLDER ABOVE THE AMOUNT IT IMPOSED IN THE FIRST YEAR THE INDIVIDUAL QUALIFIED THAT RESIDENCE HOMESTEAD EXEMPTION.
